## RIGHTS OF INTERMENT –SURRENDERS

Where a Right of Interment to an interment site is surrendered back to the Trust, a refund may be applicable. The refund is calculated in accordance with section 82(2) of the Act. An maintenance fee is applicable and is gazetted in accordance with the Act, with a sliding scale set by the Department of Health.
